PNM SUBSTATION PUBLIC ARTS MURAL

UHA, the City of Albuquerque and PNM have agreed to move forward with plans for a mural along the Silver Avenue side of the Cornell Avenue PNM substation. PNM has authorized the use of the site and agreed to supervise the safety aspects of the project. The City Public Arts Office plans to budget \$20,000 for the mural, oversee its execution, and select an artist via an open, nation-wide competition. UHA applied for and received a \$15,000 PNM Resources Foundation Power Up grant to pay for the preparation of the site and has agreed to secure \$2,000 in donations to cover the cost of stipends for design finalists. Installation of the mural is planned for spring 2017. The competition for the muralist selection will be announced by the Public Arts office later this year. UHA residents can expect updates in future newsletters and at uhanm.org. UHA for some time has envisioned a mural at this location and is excited to have found the community partners to move this project forward.

LEAD AND COAL AVENUE SAFETY CONCERNS CONTINUE

UHA remains concerned about and continues to respond to safety problems along Lead and Coal Avenues. District 6 Councilor Pat Davis, council staff, and UHA are reviewing newly available crash data and hoping it will help identify options for mitigation. The Department of Municipal Development (DMD) has ruled out one proposal: lane narrowing in order to slow speed. This measure was employed on Lead and Coal between Broadway and I-25 but DMD says lanes in our area are too narrow already to permit further reduction. As has always been the case, safety concerns exist all along the corridor. District 2 Councilor Isaac Benton has recently introduced a bill to install traffic signals at Walter on Lead and Coal, with the intention of slowing speed in the Huning Highlands neighborhood. We encourage people to take pictures and document accidents and property damage along Lead and Coal and send them to UHA. WHAT'S HAPPENING WITH ART?

ART is the Albuquerque Rapid Transit, which would replace the current Rapid Ride buses on Central Avenue with new buses running on dedicated lanes and stations in the median. The UHA board and many neighborhood people and businesses have been paying attention to the project development for more than three years. UHA's concerns have been expressed through various letters and at a numerous meetings. See <u>www.uhanm.org</u>.

In April, two lawsuits were filed by businesspeople and individuals to stop about \$70 million in federal funds being given to the City until there are environmental reviews and public meetings. If the lawsuits do not succeed, construction in the UHA area is scheduled to begin in August.
