- E. Bricklight development proposal Joe, Julie, and Don met with Allen Lewis and Jay Rembe of the Bricklight Partners on February 19. They are starting the process of developing the rest of the west side of the 100 block of Harvard. There is a California developer that has contacted them about doing a bigger development, to include the east side of the 100 block of Yale, including the Blood Plasma Center building.
