#### PROPOSED BYLAWS CHANGE

At the annual meeting members will be asked to vote to amend the UHA bylaws, sections 3.A., 3.B., 3.C, and 3.D to eliminate the specific membership dues amounts for neighborhood, business, sponsors, and senior citizens and students and substitute "as determined by the board of directors." The intent of the amendment is to allow the board of directors to periodically change the annual membership dues amounts, since the existing amounts have not changed in more than 30 years. If approved by the majority of voting members at the annual meeting, the change would become effective in January 2016.

### **NEW CENTRAL AVENUE BUSES?**

Mayor Berry and ABQ Ride have been promoting a Bus Rapid Transit (BRT) system for Central Avenue from the west side to Louisiana Ave. Later this year, the city will apply to the federal government for approximately \$75 million for the BRT system, about 75% of the construction costs.

UHA and other nearby neighborhood associations support improved mass transit on Central Avenue and throughout the city, and have encouraged people to participate in the various public meetings that have been held during the past two years. On November 10, UHA sponsored an informational meeting with city officials that several dozen neighborhood residents and business people attended to view proposed designs for the BRT in this area, to ask questions, and make comments. On December 19, UHA sent a letter to city officials detailing opposition to current proposed designs and support for alternatives that would improve safety. ### SILVER BLVD SAFETY IMPROVEMENTS

For several years, UHA has asked the city to undertake a study of traffic volumes, speeds, and accidents and to then incorporate changes to make the street safer.

On November 13, 2014, officials from the City Council, Municipal Development and Transit departments, and UHA President Joe Gallegos met to discuss existing problems with Silver and the specific things that a traffic study should investigate. This spring a study could be done, including:

- A count of motor vehicle traffic, speed, and on-street parking
- 2. A count of bike, pedestrian and skate board traffic and direction they are traveling
- 3. A clear site safety check where the northsouth alleys intersect with Silver
- Improved pedestrian crossings at Cornell, Stanford and Harvard
- A field observation as to how well motor vehicles, bicyclists and skate boarders share the road.
