The site development is to be submitted to the Design Review Board in the next several days. IDO changes are starting but none specifically affect our neighborhood. Regarding rental assistance, most landlords seem to be reporting that not too many people are having rent payment problems. Regarding the new construction on 400 block of Stanford, there are concerns about what they are or are not doing on the south side of the property. Sherry also is concerned about the big signs on Lead and Stanford, so she'll look at the ordinance.
